In addition to the above, there are general practices and pharmacies that are funded in accordance with the PHO and Integrated Community Pharmacy Services Agreement respectively.

3.2 How is the annual budget for the community services listed in the table in 3.1 set?

The annual budget for these services is based on historical need with inflation and population-based increases applied annually for both Auckland DHB and Waitemata DHB. As new initiatives are developed and implemented, the budget is adjusted accordingly.

3.3 How does the DHB apply the annual rural adjuster funding to the benefit of each of the rural communities listed in the table in question 3.1?

The Rural Adjuster Funding is used to not only support the services listed in 3.1 above but also assists in the provision of DHB community services for both rural and urban communities within both districts. As such, the Rural Adjuster Funding is not allocated directly but added to baseline funding to support the delivery of community-based services for our rural populations in both Auckland DHB and Waitemata DHB.

An example of this is the additional budgets both DHBs have added to enable provider services such as Primary Options for Acute Care (POAC) to proactively support patient management/treatment in our rural general practices. The Rural Ferinject pilot project is funded through this mechanism.

Another example of this is services such as Community Alcohol and Drugs, Primary Mental Health, Dental (primary and preschool children) and Home and Community Support Services which are provided for the populations in both DHBs. Rural populations, therefore, receive these services as part of the wider district service-delivery.

- 4. For each of the past three years, under each of the components of the Rural Adjuster, quantify the allocation of Rural Adjuster funding through the DHBs contracts with its contracted providers or Service Level Alliance Teams.
 - Small hospital facilities
 - Community services
 - Offshore Islands
 - Travel and Accommodation
 - Inter hospital transfers
 - Governance
 - Rural GP/PHO payments

Auckland DHB and Waitemata DHB do not specifically allocate funding under the above components (see 3.3 above).

- 5. i. Does the DHB include reporting requirements specific to the use of rural adjuster funding in its contracts with service-providers whose contract includes rural adjuster funding?
 - ii. If yes, provide a list of the reporting requirements included in the DHB contracts with these providers.

No. Auckland DHB and Waitemata DHB do not have reporting requirements specific to the use of the Rural Adjuster Funding.
