Thank you for your Official Information Act request received 6 September 2021 seeking information from Waitematā District Health Board (DHB) about the amount spent on acute admissions for the last five years for Māori and non-Māori within the Waitemata DHB population.

You requested the following information:

The amount of funding spent on acute admissions per year for the past five years as a total, Māori, non-Māori, and for each of these categories as per capita for the total DHB population, Māori and non-Māori populations?

On 8 September, we contacted you to advise that it was necessary to extend the timeframe on our response until 1 November as our clinicians, managers and staff were concentrating on measures to manage the COVID-19 Delta outbreak in the region.

In response to your request, we can provide the information you are seeking on the following page:


