Re: OIA request - PGY 1 House Officer positions

Thank you for your Official Information Act request received 28 December 2019 seeking information from Waitematā District Health Board (DHB) about the number of PGY 1 House Officer positions advertised.

Before responding to your specific questions, it may be useful to provide some context about our services.

Waitematā DHB serves a population of more than 630,000 across the North Shore, Waitakere and Rodney areas, the largest and one of the most rapidly growing DHBs in the country. We are the largest employer in the district, employing around 7,500 people across more than 80 different locations.

In addition to providing services to our own population, we are also the metropolitan Auckland provider of forensic psychiatry, child disability services, child community dental services and community alcohol and drug services.

In response to your request, we are able to provide the following information:

The total number of PGY 1 House Officers positions advertised solely for NZREX graduates (2014 - 2020). Please break down the data by year (e.g., 2014 = XX, 2015 = XX, etc).

Across the three Auckland metro DHBs, recruitment into RMO positions is not done on an individual DHB basis. Advertising for positions is regional and PGY1 House Officer positions are not advertised solely for NZREX graduates. Therefore, the number of House Officer positions advertised soley for NREX graduates is zero for each year from 2014 - 2020.

 Could you please provide me with the total number of hired doctors by year (2014 -2019)

We have interpreted this request as related to RMO PGY1 recruitment. The table below provides the number of PGY1 House Officers hired by Waitematā DHB who came through the ACE (Advanced Choice of Employment) system from 2014 to 2019.
