Re: OIA request - Number of hospital admissions with malnutrition

Thank you for your Official Information Act request received 18 February seeking information from Waitematā District Health Board (DHB) about the number of people admitted to hospital with malnutrition.

Before responding to your specific questions, it may be useful to provide some context about our services.

Waitematā is the largest and one of the most rapidly growing DHBs in the country, serving a population of around 650,000 across the North Shore, Waitakere and Rodney areas. We are the largest employer in the district, employing around 8,500 people across more than 80 locations.

In addition to providing care to our own resident population, we are the Northern Region provider of forensic mental health services and child rehabilitation services, plus the metro Auckland provider of child community dental services and community alcohol and drug services.

In response to your request, we can provide the following information:

The number of children and adults admitted to hospital with malnutrition, broken down by age, between January 1, 2015 and December 31, 2020.

For the purposes of extracting the information you are seeking, we have used the following ICD (International Classification of Disease) codes which relate to malnutrition:

E46	Unspecified protein-energy malnutrition
E44.0	Moderate protein-energy malnutrition
E44.1	Mild protein-energy malnutrition
E43	Unspecified severe protein-energy malnutrition
E41	Nutritional marasmus
E42	Marasmic kwashiorkor
025	Malnutrition in pregnancy, childbirth and the puerperium
T74.8	Malnutrition due to neglect, child

People who are admitted to hospital with malnutrition are referred to our dietitian service.

Our dietitians are part of multidisciplinary teams within Waitematā DHB and work with adults and children, alongside their family/whānau/caregivers, who require nutrition input related to medical and surgical treatments and/or the management of chronic conditions. The dietitians work with patients and their supporters to achieve their goals, offer nutrition education and provide follow-up care as needed.

The information requested is provided in the table below. Where numbers are less than three, we have provided the figure as "<3" to prevent individual cases being identified. This information is withheld under Section 9(2)(a) of the Official Information Act 1982 to protect privacy.
