Re: OIA request - Spend on locum services in specific departments

Thank you for your Official Information Act request received 30 September 2020 requesting information from Waitematā DHB about spend on locum services in specific departments.

Before responding to your specific questions, it may be useful to provide some context about our services.

Waitematā DHB serves a population of more than 630,000 across the North Shore, Waitakere and Rodney areas, the largest and one of the most rapidly growing DHBs in the country. We are the largest employer in the district, employing around 8,500 people across more than 80 locations.

In addition to providing services to our own population, we are also the metropolitan Auckland provider of forensic psychiatry, child disability services, child community dental services and community alcohol and drug services.

In response to your request, we are able to provide the following information:

- 1. What has the DHB spent on locums for medical specialists every year for the past five years in the following departments:
  - General surgery
  - Orthopaedics
  - Enterology
  - Gynaecology
  - Ophthalmology
  - Urology
  - Cardiology

Could I please have the total locum spend year-by-year over this period, as well as the total internal staff spend on specialists for the same periods?

Please note that the following locum costs make up a small proportion of Senior Medical Officer (SMO) payroll costs and total funding budget of \$1.846 billion.

## 2. What is the size of the population the DHB serves and what is its annual operating budget?

The population the Waitematā DHB provides services to is estimated at 630,000-plus residents.

3. It would also be helpful to have explanations for higher (or lower) than usual locum costs for particular periods and whether or not the DHB offers limited services in respective departments.

Some of the lower-than-usual locum costs in 2019/20 are due to a combination of non-urgent (elective) planned care being suspended during the COVID-19 response and reduced staffing vacancies that have resulted from a less-transient work population due to the pandemic.

Other variations in locum spend across years can be attributed to cover for a range of leave requirements such as sickness, maternity leave and study leave as well as the availability of suitably qualified SMOs for particular specialties or sub-specialties.

I trust that this information is helpful.

Waitematā DHB supports the open disclosure of information to assist community understanding of how we are delivering publicly funded healthcare. This includes the proactive publication of anonymised Official Information Act responses on our website from 10 working days after they have been released.

If you consider there are good reasons why this response should not be made publicly available, we will be happy to consider your views.
